

# Massachusetts Acute Hospital and Health System Financial Performance

Hospital Fiscal Year Data through March 31, 2023



## JULY 2023

### About this Report

The Center for Health Information and Analysis (CHIA) reports quarterly on the financial performance of the Commonwealth's acute care hospitals, associated hospital health systems (HHS), and affiliated physician organizations. This report provides a quarterly update on profitability, liquidity, and solvency for the hospital fiscal year-to-date period ending March 31, 2023, hereafter also referred to as the current period.

Including HHS and affiliated physician organizations helps develop a more complete understanding of the financial performance of an acute hospital in the context of the larger health system within which it operates. Steward Health Care provided a partial submission that included hospital data but did not include the required HHS or physician organization data. Shriners Hospital for Children – Springfield terminated acute care services in HFY 2022 and therefore no longer submits quarterly financial data.

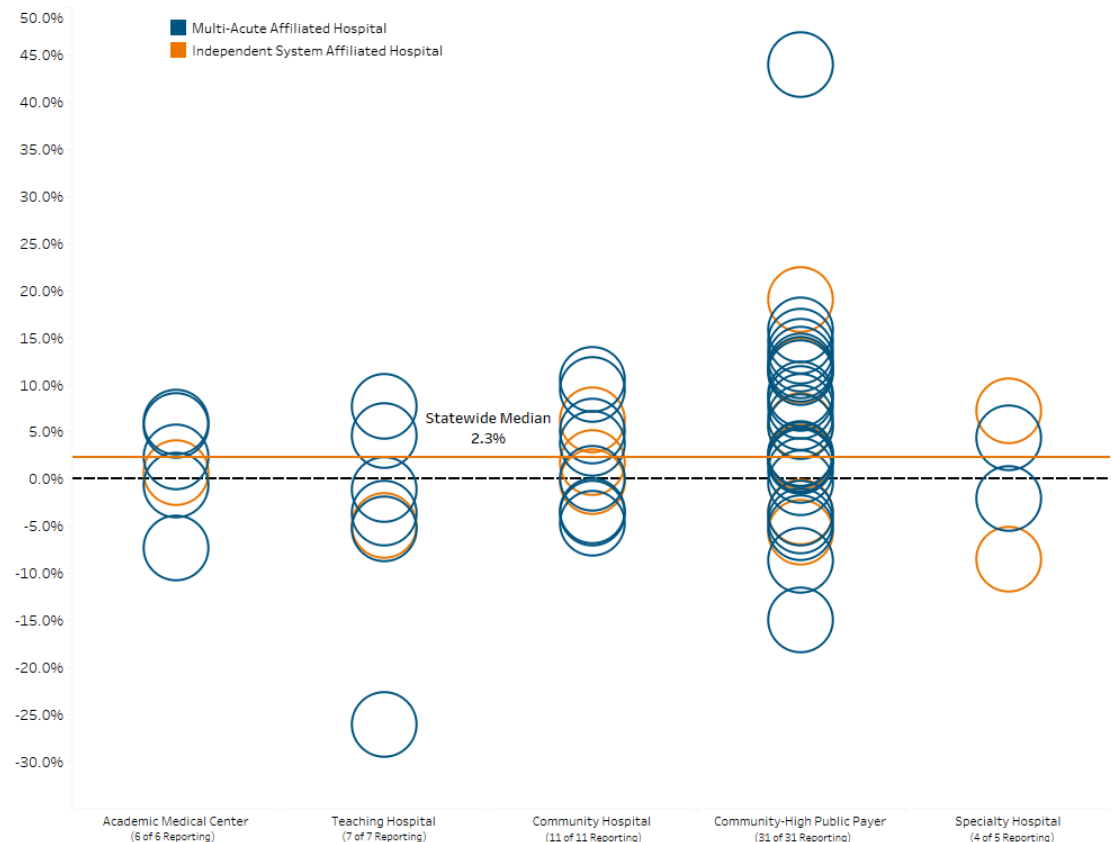
Federal and state COVID-19 relief funding was first distributed to hospitals in April 2020 and further relief funding has been distributed since. A portion of this funding is reported as operating revenue and is reflected in the data as such.

### Key Findings

#### Profitability: Hospitals

Overall acute hospital profitability,<sup>1</sup> as measured by the median total margin, was 2.3%, an increase of 5.4 percentage points in comparison to the same period in the prior year (figure 2). Thirty-eight of the 60 hospitals (63%) reported positive total margins during this period.

Figure 1: Acute Hospital Total Margin by Hospital Type



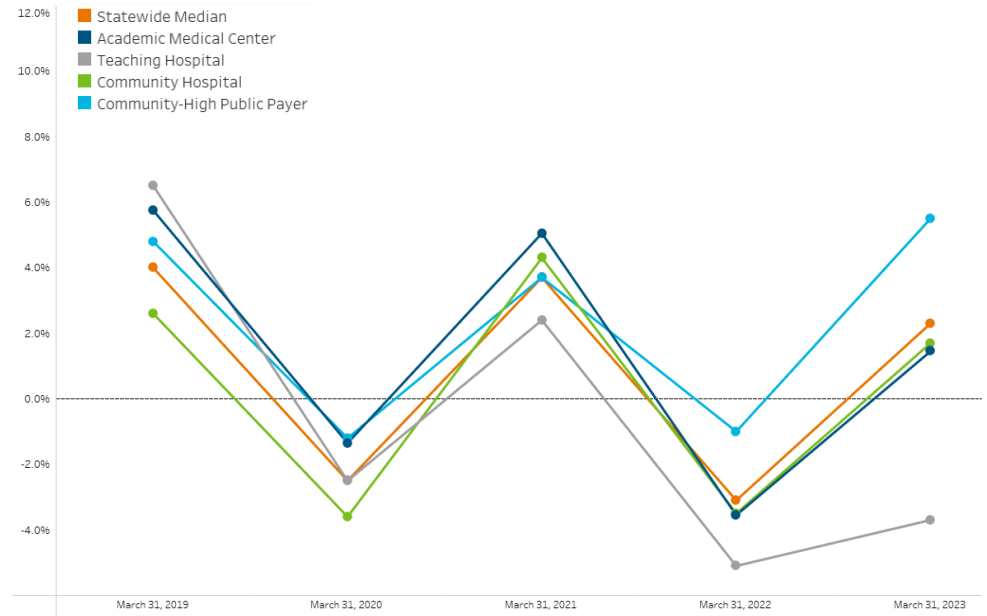
<sup>1</sup> Profitability or profit indicates an excess of revenues over expenses.

All four cohorts<sup>2</sup> experienced an increase in median profitability when compared to the same period last year. The community-HPP cohort had the highest median total margin and was only cohort above the statewide median. The teaching hospital cohort was the only cohort with a negative median total margin.

In aggregate, hospitals reported \$251.6 million in federal and state COVID-19 relief funds as operating revenue during the current period. This revenue is included in their total margins.

<sup>2</sup> Acute hospital cohort designations are Academic Medical Center (AMC), Teaching Hospital, Community Hospital, and Community-High Public Payer (HPP). Specialty Hospitals are not considered a cohort. For further descriptions of the cohorts and specialty hospitals, see the technical appendix.

**Figure 2: Median Total Margin by Hospital Cohort**



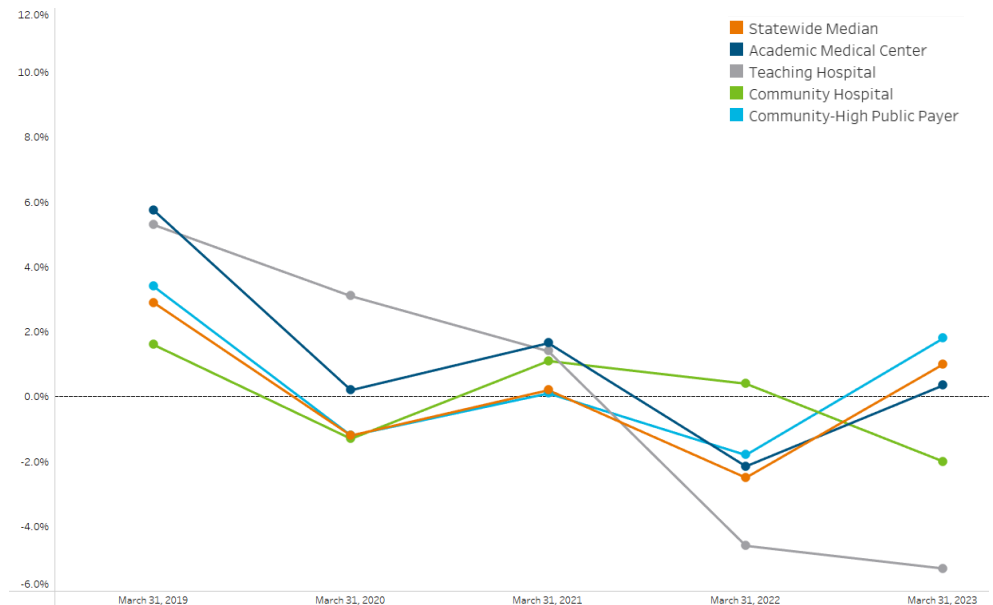

The statewide median operating margin was 1.0%, an increase of 3.5 percentage points compared to the same period in the prior year.

The teaching hospital and community hospital cohorts reported decreases compared to the same period prior year and both reported negative median operating margins. The AMC and community-HPP cohorts reported an increase compared to the same period in the prior year.

These margins also include COVID-19 relief funding reported as operating revenue.

**Figure 3: Median Operating Margin by Hospital Cohort**



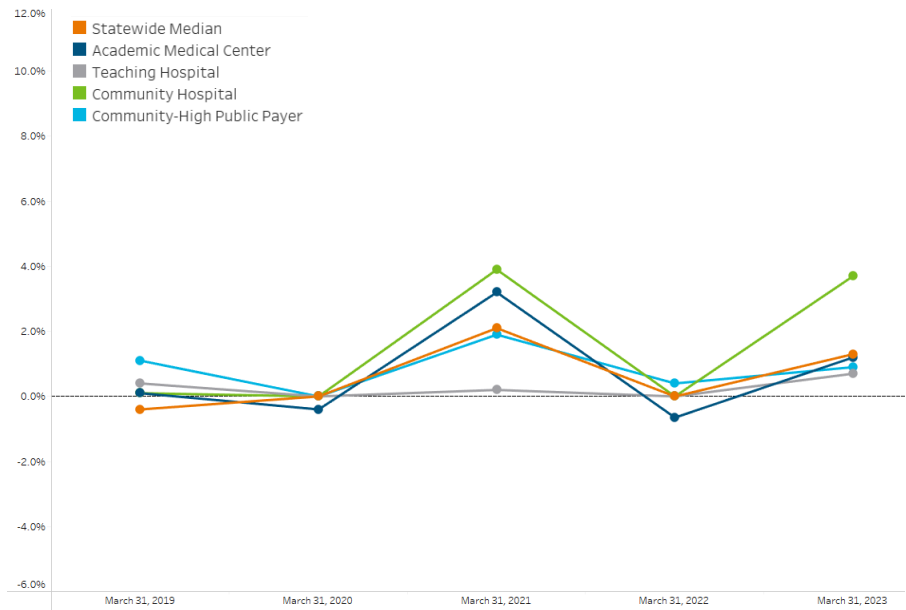

The statewide median non-operating margin was 1.3%, an increase of 1.3 percentage points compared to the same period last year.

All four cohorts saw an increase in their median non-operating margins compared to the same period last year. The teaching hospital cohort reported the largest change in median non-operating margin, an increase of 3.7 percentage points.

Non-operating margins are influenced by changes in the investment markets. Starting in FY 2020, accounting standards required realized and unrealized gains be recognized in financial performance. These results are included in the non-operating margins in this report.

## Revenue and Expenses

Aggregate total operating revenue increased by \$1.7 billion (9.1%), of which aggregate net patient service revenue, the most significant component of operating revenue, increased by \$1.1 billion (5.7%) when compared to the same period in the prior year. Aggregate expenses increased \$1.4 billion (7.5%) when compared to the same period in the prior year.

Through March 31, 2023, hospitals reported \$251.6 million in federal and state COVID-19 relief funds in their operating revenue, as compared to \$229.4 million in the same period the prior year.

**Figure 5: Hospital Operating Revenue and Expenses Trends**

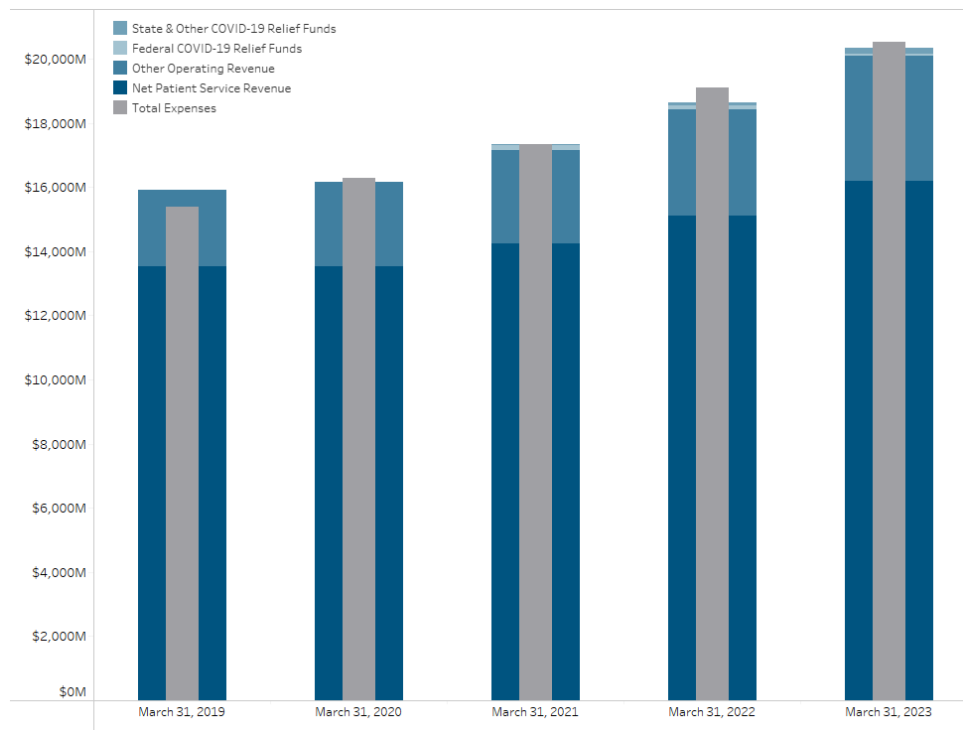
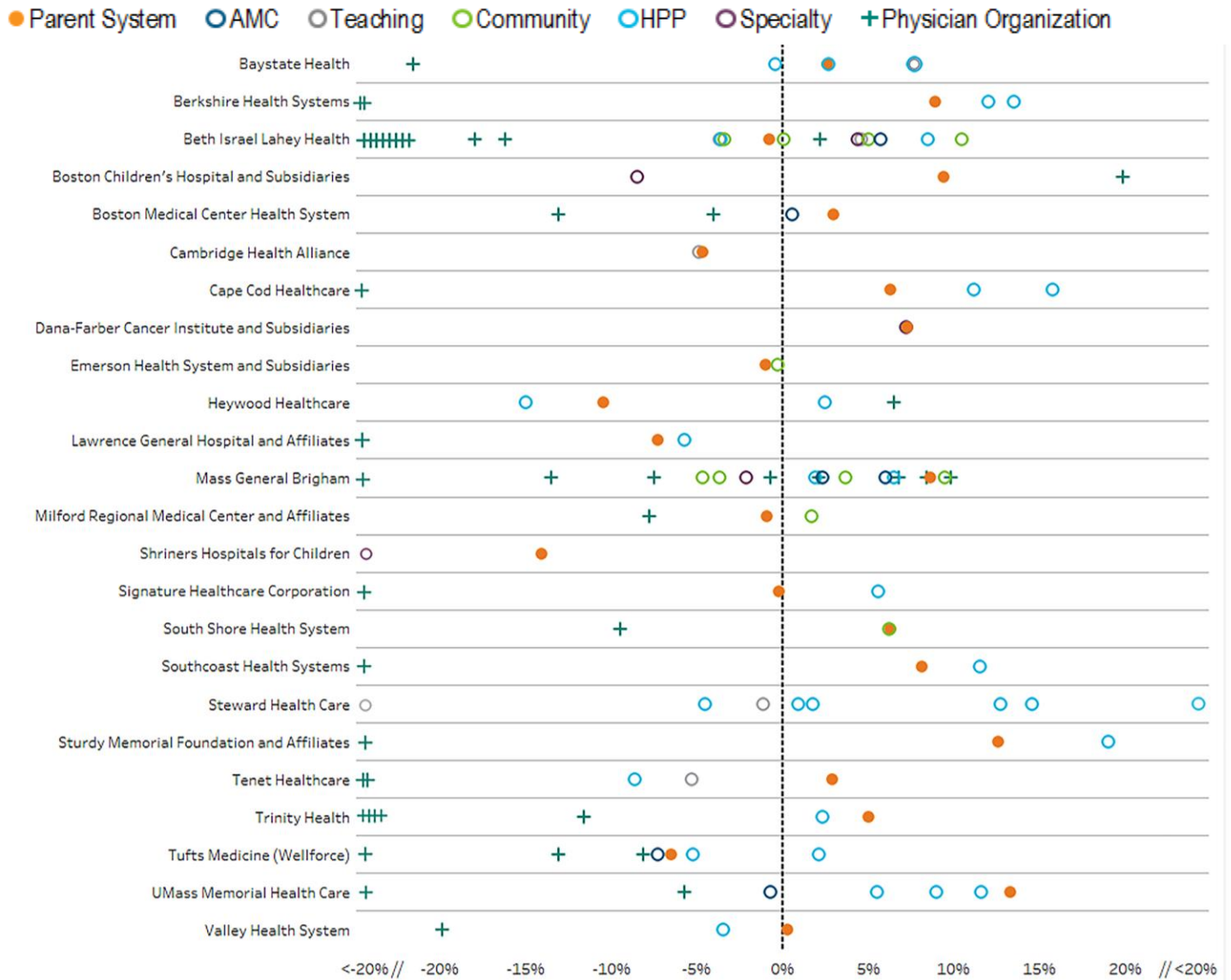


Figure 6: Total Margin of Hospital Health Systems, Acute Hospitals, and Affiliated Physician Organizations



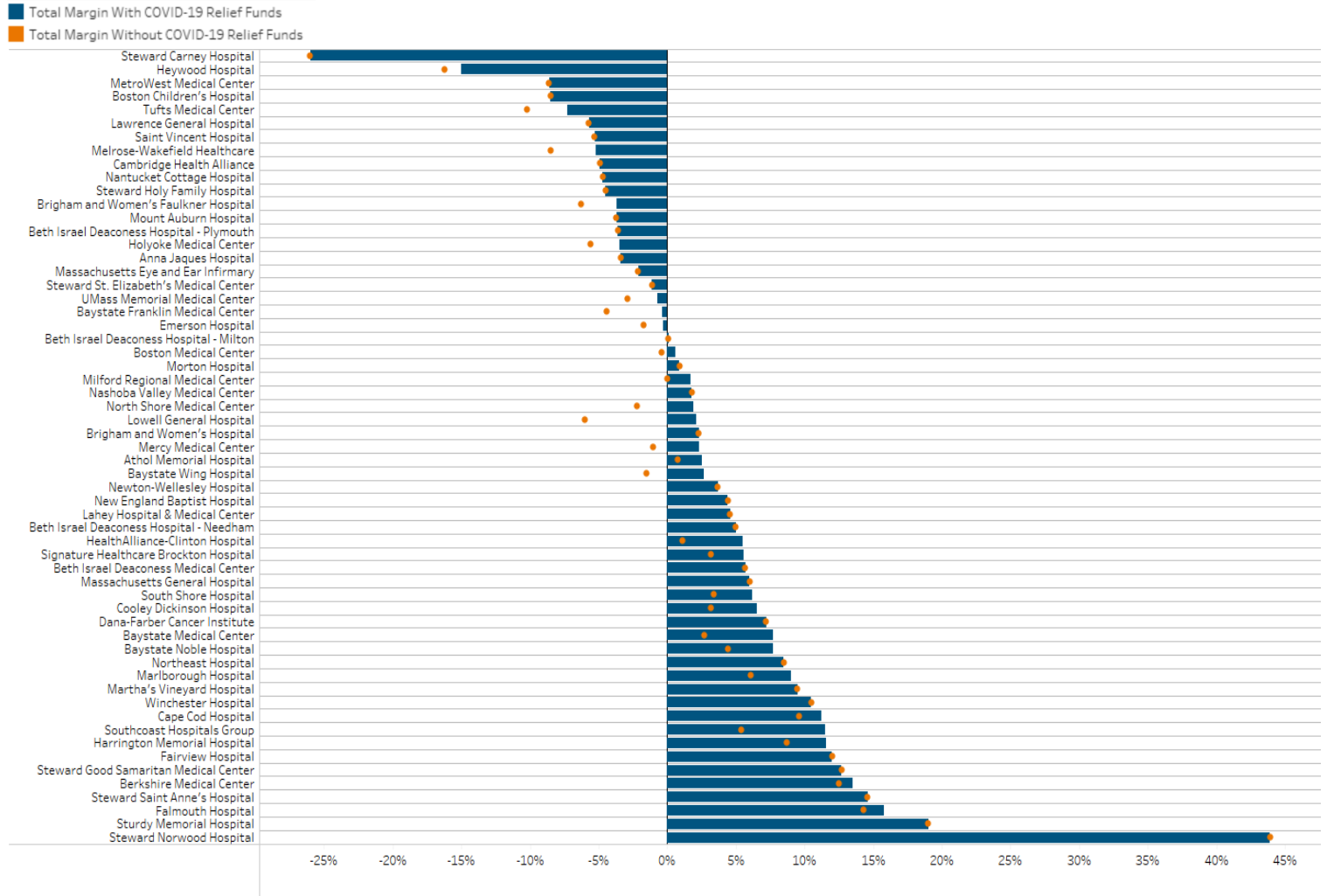

### Profitability: Hospital Health Systems and Physician Organizations

As of March 31, 2023, 14 hospital health systems were profitable and reported a positive total margin, while the remaining 9 systems that reported data had negative total margins. For the same period in the prior year, seven hospital health systems reported positive total margins, while the remaining 15 systems reported negative total margins. The median operating margin for hospital health systems was -2.8%, while the median non-operating margin was 3.5%. For most health systems, this data reflects second quarter results and may not be indicative of their final annual financial performance.

Thirty-nine of 46 affiliated physician organizations reported a net loss for the period ending March 31, 2023.

This support is provided through transfers from the SHC's endowment to the hospitals, as these transfers are not considered revenue for the purpose of calculating profitability margin, SHB's profitability margins are not comparable to other acute hospitals. ## REPORT NOTES

### Description of Financial Metrics

Financial ratio analysis is one critical component of assessing an entity's financial condition. As part of this quarterly financial performance report, the Center for Health Information and Analysis (CHIA) collects data and reports on profitability, liquidity, and solvency metrics. The measures are used for hospitals and hospital health systems. The physician organizations only report on profitability metrics. Below are the descriptions and calculations for each.

#### Operating Margin

Operating income is income from normal operations of an entity, including patient care and other activities, such as research, gift shops, parking, and cafeteria, minus the expenses associated with such activities. Operating margin is a critical ratio that measures how profitable the entity is when looking at the performance of its primary activities.

Of note, some federal and state COVID-19 relief funds received may be included in the entity's operating income.

Operating Margin = (Total Operating Revenue - Total Expenses Including Nonrecurring Gains Losses) / Total Unrestricted Revenue, Gains, and Other Support

#### Non-Operating Margin

Non-operating income or loss is net of expenses and includes items that are not related to operations, such as investment income, contributions, gains from the sale of assets, and other unrelated business activities.

Non-Operating Margin = Total Non-Operating Revenue / Total Unrestricted Revenue, Gains, and Other Support

#### Total Margin

This ratio evaluates the overall profitability of the entity using both operating surplus (or loss) and non-operating surplus (or loss).

Total Margin = Total Excess of Revenue, Gains, and Other Support Over Expenses / Total Unrestricted Revenue, Gains, and Other Support

#### COVID Funding in Operating Revenue

This metric sums all sources of COVID-19 relief funding that was recorded as other operating revenue in the financial statements during this reporting period. This may include COVID-19 relief funding received under the CARES Act, HHS public health and social service emergency funds, private foundation grants or contributions, or state relief funds.

COVID Funding in Operating Revenue = Other Operating Revenue: Federal COVID-19 Relief Funds + Other Operating Revenue: State & Other COVID-19 Relief Funds

#### Current Ratio

This ratio measures an entity's ability to meet its current liabilities with its current assets. A ratio of 1.0 or higher indicates that current liabilities could be adequately covered by the entity's existing current assets.

Current Ratio = Total Current Assets / Total Current Liabilities

## Other Measures

The following are individual line items from the hospital and health system standardized financial filing:

- **Total Excess of Revenue, Gains, and Other Support Over Expenses:** Total dollar amount of surplus or loss derived from all operating and non-operating activities
- **Net Patient Service Revenue (NPSR):** Revenue an entity would expect to collect for services provided, including premium revenue, less contractual allowances. NPSR is the primary source of revenue for an entity.
- **Other Operating Revenue: Federal COVID-19 Relief Funds:** Revenue an entity received from the federal government related to the COVID-19 pandemic and reported as operating revenue.
- **Other Operating Revenue: State & Other COVID-19 Relief Funds:** Revenue an entity received from the state government or source other than the federal government related to the COVID-19 pandemic and reported as operating revenue.
- **Net Assets:** For not-for-profit entities, this represents the difference between the assets and liabilities of an entity, comprised of retained earnings from operations and contributions from donors. Changes from year to year are attributable to two major categories: (1) increases and/or decreases in Unrestricted Net Assets, which are affected by operations, and (2) changes in Restricted Net Assets (restricted contributions). The for-profit equivalent of Total Net Assets is Owner's Equity.

## Data Caveats

Data represents the period through March 31, 2023 and is not necessarily an indication of the financial position that an entity will have at its hospital fiscal year end.

Effective July 1, 2021, Harrington Healthcare System became part of with UMass Memorial Healthcare. The HFY22 and HFY23 data for UMass Memorial Healthcare includes both Harrington Memorial Hospital and Harrington Physician Services.

Shriners Hospital for Children – Springfield terminated acute care services in HFY 2022 and therefore no longer submits quarterly financial data.

All COVID Funding metrics are presented as reported by the hospital or entity.

There was an accounting change (ASU 2016-01) adopted by most hospitals beginning in HFY 2020 in which unrealized gains and losses on investments are recognized as non-operating income.
