APPLICATION REMINDERS

Fee Waiver Request Reminders

- 1. If you're submitting a request for a fee waiver, remember to include the fee remittance form in your application package on IRBNet.
- 2. Remember to submit supporting documentation (if required).
- 3. If you're requesting a financial hardship waiver, remember to submit information detailing your project's financial situation (examples: project budget, grant funding, organizational / departmental funding). Also request to pay a specific price that you reasonably believe you're able to afford to contribute.
- 4. CHIA generally does not offer full financial hardship fee waivers. We expect all applicants to have made an attempt to find funding to cover the full cost of the data fees.
- 5. Fee waiver requests can take some time to process especially financial hardship requests.



Medicare Advantage

Original Medicare

- Medicare Part A (Hospital Insurance)
- Medicare Part B (Medical Insurance)
- Beneficiaries can add Medicare Part D (Drug Coverage).
- Beneficiaries can use any doctor or hospital that takes Medicare, anywhere in the U.S.



 Medicare Advantage is an "all in one" alternative to Original Medicare. These "bundled" plans include Part A, Part B, and usually Part D.

- In most cases, beneficiaries need to use doctors who are in the plan's network.
- Most plans offer extra benefits that Original Medicare doesn't cover-like vision, hearing, dental, and more.

MEDICARE DATA

Question: MA APCD release 7.0 documentation indicates Medicare data is released only to government agencies. However, the MA APCD submission guides include product codes for Medicare. Is commercial carrier Medicare data available to non-government applicants? What type of Medicare products are included in the MA APCD and on how many beneficiaries?

option of receiving Medicare through commercial carrier "Medicare Advantage" plans which can include hospital, medical and pharmacy benefits. Claims data from commercial carrier supplemental coverage, pharmacy benefit managers, and Medicare Advantage plans submitted to the MA APCD are available to all applicants. According to CMS's 2019 product guide **, the difference between Original Medicare and Medicare Advantage products is as follows:

Answer: CHIA receives Medicare data ("Original Medicare") from the Centers for Medicare & Medicaid Services (CMS) under a Data Use Agreement (DUA). Under terms of the DUA, CHIA only releases Original Medicare data to government* applicants. Original Medicare beneficiaries can obtain supplemental coverage through commercial carriers and have the

Answer (continued): To gauge the number of beneficiaries who have any type of commercial Medicare products in the MA APCD as a proportion of the Massachusetts population, we assessed both medical coverage of the entire population as a proportion of the Census population and coverage for any Medicare product types as a proportion of the population 65 and older.



In Table 1 below, MA census population* for 2013 to 2017 (first column) and all MA residents with medical coverage in the APCD (second column) show that data from 2013 to 2015 was close to population-based (over 95%) followed by a drop to 85% in 2016 (due to Gobeille). This drop was corroborated by comparing the Census American Community Survey estimate on insured population** under 65 years old (third column) to APCD beneficiaries under 65 with medical coverage (fourth column). In Table 2, census estimates for MA residents age 65 and over (first column) were compared to 65 and older age group in the APCD with different types of Medicare coverage (columns 2 through 7). Year 2017 showed increases for all products except Medicare Advantage, however the proportion of the population age 65 and over in the MA APCD with Medicare Advantage (26.86%) was closely aligned with CMS historical data on Massachusetts resident year 2017 Medicare Advantage enrollment (26.42%).***

<u>Question</u>: There is an "<u>Insurance Type Code Product</u>" field in claims data (MC003, PC003, DC003) and in eligibility data (ME003). In the product file, there is also a field called "<u>Product</u> <u>Line of Business</u>" (PR004) which appears to have similar coding options to "Insurance Type Code Product." Are there any differences in the coding options from one MA APCD table to another?

Insurance Type Code Products



Answer: Based on the CHIA 2019 All Payer Claims Data Submission Guides, the <u>Insurance Type Code Product</u> field in the Medical Claims, Pharmacy Claims, Dental Claims and Member Eligibility files contain the same 40 coding options across all four file types. The Product file's <u>Product Line of Business</u> field contains 36 coding options. The Insurance Type Code Product field and Product Line of Business field have 24 product definitions in common, see Table 1 below)

<u>Answer</u> (continued): While the claims, eligibility and product files contain 24 shared definitions, the claims and eligibility <u>Insurance Type Code Product</u> field contain 16 definitions not found in the product file's Product Line of Business field, see Table 2 below. The product file's <u>Product Line of Business field</u> contains 11 fields not found in the claims and eligibility file, see Table 3 below. Please note that while Product Line of Business contains a Medicare code (MR), the claims and eligibility Insurance Type Code Products contain the more granular definitions of Medicare Part (MA), Part B (MB), and Part D (MD).


