After submitting a completed Exhibit B you will receive an invoice (if applicable) for the requested data. Upon payment of the invoice the order for the data will be placed.
- CY 2020 Data includes data on services from January 2016 –
 December 2020 with six months of claim runout.

While the MA APCD has a Master Patient Index (Member Link EID) to analyze distinct patients across carriers, it does not have a Master Provider Index. Although Medicare's National Provider Identifier (NPI) can be used, which Medicare requires all enrolled individual practitioners and organizational providers to have, atypical providers such as certain transportation providers and respite providers might not have an NPI.

CHIA defines a provider as an entity associated with either: 1. providing services to patients 2. submitting claims for services on behalf of a servicing provider 3. providing business services or contracting arrangements for a servicing provider. All critical fields to use for MA APCD between table linkage with the provider table are embedded with the word **linkage_id** at the end field name. These fields link to the linkingproviderid (PV002) in the provider table in combination with linkingorapy which links to orgid in the provider table.



users should carefully review the release documents before proceeding to link data.


For example, a carrier may have reported during one submission month an inadvertent transposition of a digit that could impact linkage.


For example, for ME046 (Member PCP ID) carriers report the PCP identifier for members with a corresponding ID in the Provider File, only used for members whose insurance requires the selection of a primary care physician (e.g., HMO or POS plans). For ME124 (Attributed PCP ID) carriers report PCPs attributed to the members whose insurance products do not require the selection of a primary care physician (e.g., PPO plans or indemnity products). This attribution is based on the carrier's

own attribution methodology.

Even though there is a high completeness of the PCP ID in the member eligibility file (see figure 1), the missing PCP ids were not accounted for by the attributed PCP IDs. Except for calendar Year 2014, most of the attributed PCP IDs (see figure 2) had both a PCP ID and an attributed PCP ID.


Remember both active and inactive are in the provider table. Providers inactive prior to January 2015 are no longer submitted. Carriers are asked to report any and all provider information that aligns to the eligibility and claims data to insure that linking can occur.





The MA APCD LDS Provider Table only contains twelve (12) data elements (see Table below). For this reason, many data applicants request the national provider ID (NPI) for the purposes of linking it to provider to external repositories. CMS provides the following definition and explanation of the NPI.

PROVIDER EXTERNAL LINKAGE DATA



What is a National Provider Identifier (NPI)

The Health Insurance Portability and Accountability Act of 1996 (HIPAA) specifies the set of providers that must have NPIs as those that execute HIPAA transactions (i.e., only some Medicaid/CHIP "providers" have NPIs)

The NPI is a 10-digit national identifier assigned by the National Plan and Provider Enumeration System (NPPES)

NPPES Type 1 NPI – Individual Practitioners

NPPES Type 2 NPI – Organizational Providers and their *sub-parts*

The same organizational unit (i.e., acute care hospital) can have more than one NPI.

Organizational provider sub-parts

"Some organization health care providers are made up of components that function somewhat independently from their 'parent' organization. These components may furnish different types of health care or have separate physical locations where health care is furnished. These components and their physical locations are not themselves legal entities but are part of the organization health care provider (which is a legal entity). The NPI Final Rule refers to the components and locations as subparts." (CMS, Medical Learning Network, December 2016 909434)

Stores in a pharmacy chains and departments in hospitals are examples of organizational provider *sub-parts*

Medicare Durable Medical Equipment (DME) suppliers must have their own NPI (i.e., Pharmacy Chain Stores)

There are many challenges linking and identifying relationships between providers and provider care setting locations in linking within the MA APCD and to external data repositories. CHIA's linking provider IDs were created to reduce these challenges.



- Challenges in identity resolution among providers with multiple affiliations and sharing organizational IDs in determining provider-to-provider relationships, provider-to-organization relationships, large group practices, and multi-state hospital networks.
- · Determining the extent to which both historical and current provider data are needed based on the time period of the claims
- Resolving conflicts in provider attributes from multiple data sources
- Determining which data should be cleaned or imputed to resolve inconsistencies and assess patterns in missing data.

CHIA is currently making a conscious decision to collect numerous identifiers that may be associated with a provider:

- PV002 Plan Provider ID
- PV006 License Id
- PV007 Medicaid Id
- PV008 Last Name
- PV009 First Name
- PV036 Medicare Id
- PV039 National Provider ID
- PV040 National Provider2 ID

These identifiers will be used by CHIA in the future to create a Master Provider Data Set for analyzing providers across submitters and help link providers across carriers in the event that the primary linking data elements are not a complete match. The existence of these extra identifying elements will improve the quality of our matching algorithms


