- ➤ All APCD submissions through June 2022 are due by July 31^{st.} This includes any re-submissions.

Question				
Should inactive providers be included on the file and what is the reporting time period?	Yes, all providers, both active and inactive must be included. Providers that were inactive prior to January 20102015 are not to be included. It is necessary to report any and all provider information that aligns to the eligibility and claims data to insure that linking between files can occur.	CHIA collects the most up to date provider data that can be used to analyze claims data. Since claims data is collected monthly, the provider file can be synced with the claims file, and can be a snapshot of how the provider file looked at the end of the period for which claims are sent.
