MA APCD Intake

- ➤ All APCD submissions through March 2023 were due by April 30^{th.} This includes any re-submissions.
- ➤ Please work with your liaison in submitting any overdue files and alert them if you expect any further delays this month.
- ➤ The data through March will be used for Q1 2023 DOI Membership, bi-annual DOI Claims Utilization and CHIA's Enrollment Trends reports.

Enrollment Trends Update

- We sent requests for Supplemental enrollment data to selected payers in early April and is due back to CHIA by May 15, 2023. Supplemental enrollment reporting is requested where populations cannot be accurately sourced from the MA APCD.
- Payers will receive aggregate MA APCD Member Eligibility data for review in early June.
