MA APCD Intake

- All APCD files through December 2024 were due by January 31^{st.} This includes any re-submissions. These are needed for end of year reporting (DOI Membership – both quarterly and annual, Enrollment Trends).
- O Please work with your liaison in submitting any overdue files.
- Please be mindful when selecting the Submission Month and Year in FileSecure. If the wrong month and/or year is selected, it will deactivate previously submitted, valid files.
- CHIA continues to revisit claims versioning methods with select payers. We'll reach out when we have examples to share as we analyze the logic for each company.
- Please alert CHIA if you plan to change PBMs as that could impact pharmacy claims versioning methods.



MA APCD 2025 Submission Guide Updates

- Draft versions of the 2025 MA APCD submission guides (with updates related to CHIA's health equity strategy) are now available at: https://www.chiamass.gov/apcd-data-submission-guides
- New filing type: Demographic (DE) file
 - Includes some existing Member Eligibility data elements
 - Additional data elements added (Race, Ethnicity, Language, Sexual Orientation, Gender Identity, Disability Status, Address, Sex Assigned at Birth)
 - Will require a new version of CHIA's FileSecure application
- O Some Member Eligibility (ME) fields are changing to 'Filler' fields as a result
- ME & DE files will need to link using the Carrier Specific Unique Member ID (CSUMID)



MA APCD 2025 Submission Guide Updates

- Liaisons sent out a notification last month that the 2025 MAAPCD draft submission guides containing these updates are now available.
- We are currently in the 30 day optional comment period for payers to provide feedback. Please respond by February 28th.
- An Administrative Bulletin will be adopted in March making the changes official.
- Test files will need to be submitted in the Fall of 2025.
- Production files will be due in February 2026 for January 2026 data.
