MA APCD Intake

- All APCD files through May 2025 are due by June 30^{th.} This includes any resubmissions.
- Please work with your liaison in submitting any overdue files.
- Please be mindful when selecting the Submission Month and Year in FileSecure. If the wrong month and/or year is selected, it will deactivate previously submitted, valid files.
- CHIA continues to revisit claims versioning methods with select payers. We'll reach out when we have examples to share as we analyze the logic for each company.
- Please alert CHIA if you plan to change PBMs as that could impact pharmacy claims versioning methods.



MA APCD 2026 Submission Guide Updates

- FINAL versions of the 2026 MAAPCD submission guides are now available at: https://www.chiamass.gov/apcd-data-submission-guides
- New filing type: Member Simplified (MS) file:
 - Includes some existing Member Eligibility data elements.
 - Additional data elements added (Race, Ethnicity, Language, Sexual Orientation, Gender Identity, Disability Status, Address, Sex Assigned at Birth).
 - CHIA is requesting available data that plans currently collect and can report for these additional fields. If data is unavailable, plans can submit as "Unknown".
 - Clarity added to table values of 'OTH', 'DONTKNOW', 'ASKU', 'UNK'.
 - Will require a new version of CHIA's FileSecure application.



MA APCD 2026 Submission Guide Updates

- Some Member Eligibility (ME) fields are changing to 'Filler' fields as they are moving to the new MS file type.
- ME & MS files will need to link using the Carrier Specific Unique Member ID (CSUMID).
- The goal of moving to this new file is to shorten the time it takes for most submitters to encrypt the file using FileSecure since this is a monthly snapshot of 1 record per member rather than 24 rolling months.
- The Administrative Bulletin was adopted in April liaisons sent a notification to all submitters.
- Test files will need to be submitted in the Fall of 2025.
- Production files are due in February 2026 for January 2026 data.



MA APCD 2026 Submission Guide Updates

The submission guides for Medical Claims, Pharmacy Claims, Dental Claims, Product, Provider and Benefit Plan do not have any updates <u>EXCEPT</u> the header record will require a change to the data element 'APCD Version Number'. It is changing from '2019' to '2026' beginning with the January 2026 files due by the end of February 2026.
