MA APCD CY 2021

- Available for request
- Applicants with approved projects that require updated APCD data (CY 2021 Data) should submit to CHIA a completed Exhibit B (*Certificate of Continued Need and Compliance*) of the Data Use Agreement. After submitting a completed Exhibit B you will receive an invoice (if applicable) for the requested data. Upon payment of the invoice the order for the data will be placed.
- CY 2021 Data includes data on services from January 2019 December 2021 with six months of claim runout through June 2022.

USER QUESTIONS

<u>Question</u>: I am applying for the MA APCD medical claims data to study the impact of the surge in urgent care centers on access to non-emergent medical care in Massachusetts. I am concerned about the quality of indicators for identifying urgent care centers. How complete are the site of service codes?

<u>Answer</u>: The field **Site of Service on NSF/CMS 1500 Claims** (MC037) has a 100% filing threshold. The field must be populated when **Type of Claim** (MC094) equals '001' for professional claim. The MA APCD CY2021 Release contains 682,078,306 medical claim lines where the Type of Claim is professional. For professional claim lines from Massachusetts service providers, the **Site of Service** field is 99.99% populated. There is one site of service coding option to urgent care centers:

Site of Service Code
20Site of Service Name
Urgent Care CenterDescription
Location, distinct from a hospital emergency room, an office, or a clinic, whose purpose is to
diagnose and treat illness or injury for unscheduled, ambulatory patients seeking immediate
medical attention.




Figure 1. January 2018 through December 2021 Urgent Care Center MA APCD Medical Claim Line Volume

From January 2018 through December 2021, there has been a significant upward trend in the medical claim lines coded as **site of service '20'** for urgent care centers with the highest surge in claim line volume occurring during the winter months. See Figure 1 below.

<u>Answer (continued)</u>: In addition to the site of service field, the Service Provider Taxonomy field (MC032) In the medical claims can be used to identify urgent care providers. In this field, insurance carriers report the standard taxonomy code that defines the provider specialty for the line of service. This field has a 98% filing threshold.



The Taxonomy code for Urgent Care is 261QU0200X

The taxonomy code '261QU0200X' code can be used by medical groups or individual providers. In MA APCD CY2021 Release medical claims, the number of distinct **rendering** providers who use the urgent care taxonomy count has more than doubled from calendar 2018 to calendar year 2021. **See Table 1 below.** It is important to note that many of the top **billing** providers who use the urgent care taxonomy code are also community health centers and multigroup specialties. See Table 2 below.

<u>Question</u>: I requested the decrypted National Provider Identifier (NPI) in the MA APCD medical claims to link to the CMS National Plan and Provider Enumeration System (NPPES) NPI Registry. I am now also considering applying for the MA APCD's provider table which I understand can be linked to the medical claims via provider linkage IDs and carrier organization IDs. If I wanted to link the decrypted NPI in the MA APCD provider table to the CMS registry, I first wanted to know whether CHIA had run any integration tests to determine that the same NPIs in the medical claims data can consistently be found in the MA APCD provider table.




<u>Answer</u>: Yes, CHIA routinely conducts data integration tests between all the MA APCD tables. The NPIs in the MA APCD CY2021 medical claims have an over 99% integration with the NPIs in the provider table. **See integration test results in Table 1 below.** The less than 1% of records by year when the NPIs do not link are mostly attributable instances where an NPI was submitted with a missing digit.

Question: During the pandemic, the Massachusetts ED visit volume dropped significantly. I understand the latest release of the outpatient ED visit data is now available. Have ED visits continued to trend downward in Massachusetts?




Fig 1. ED Visit Volume by Fiscal Year: 2016 - 2022

Answer: No, even though the Massachusetts ED visit volume decreased by 18% from FY2019 to FY2020, and continued to trend downward in FY2021, the latest FY2022 release shows ED visits trending upward by 11% from FY2021 to FY2022. See Figure 1 below. The most pronounced FY2022 increase in visit volume was among the pediatric population age 17 years old and younger. See Figure 2 below.



ED Visit Volume


<u>Answer (continued)</u>: Historically, the pediatric population has a higher ED visit volume. While the pediatric (age 17 and younger) increased from 279,500 visits in FY2021 to 395,173 visits in FY2022, when the FY2022 ED visit volume is stratified both by age group and sex, the large FY2022 pediatric increase is mainly attributable to males. See Figure 3 below.



Question: Have newborns continued to trend downward in Massachusetts?

<u>Answer</u>: Also, in the most recent inpatient data, over the past six years there has been a continuous downward trend in newborns in Massachusetts. The most recent FY2022 hospital inpatient discharge data has revealed as surprising reverse in the trend. From FY2021 to FY2022, there was a 1.8% increase in Massachusetts newborns. See Figure 4 below.
