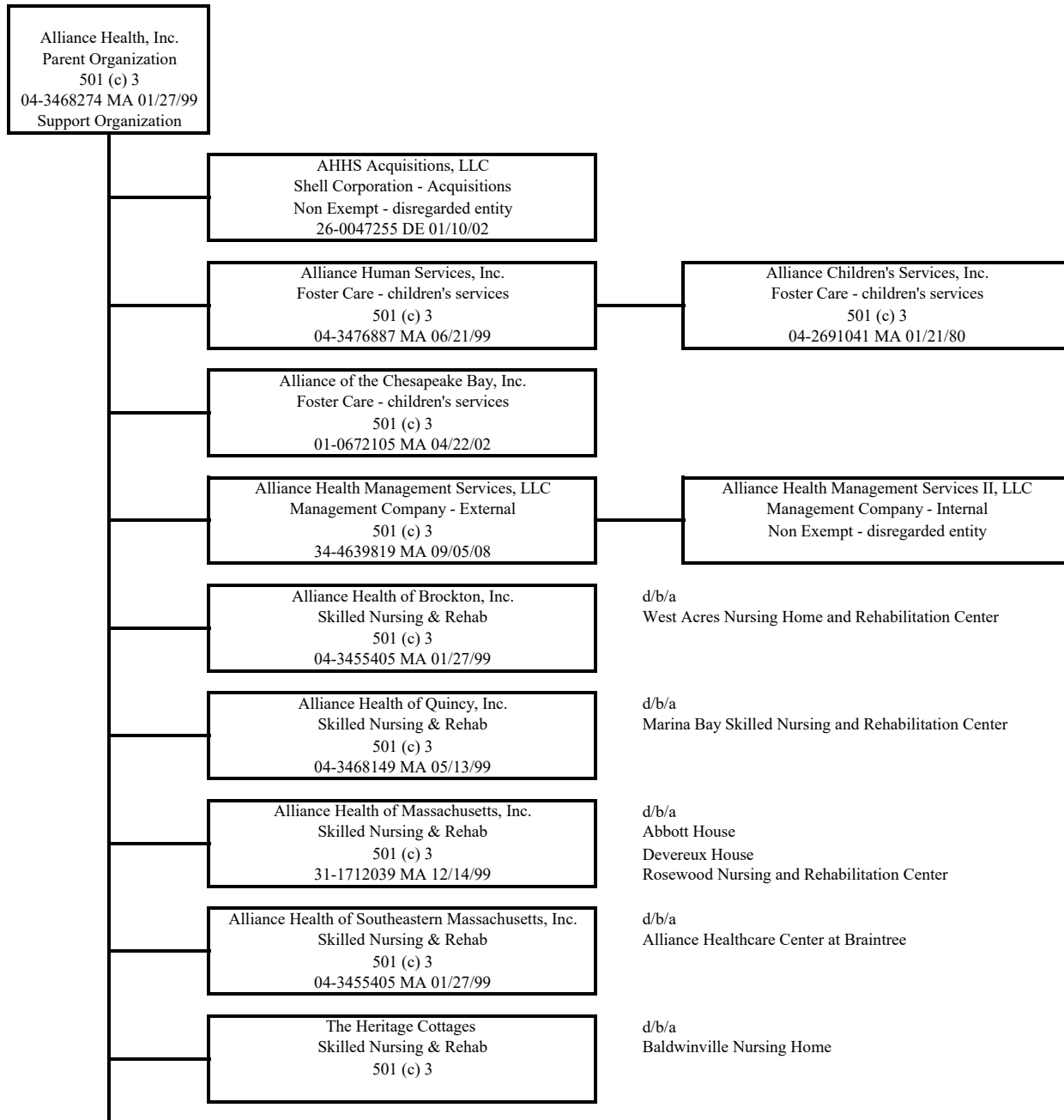

Organizational Chart

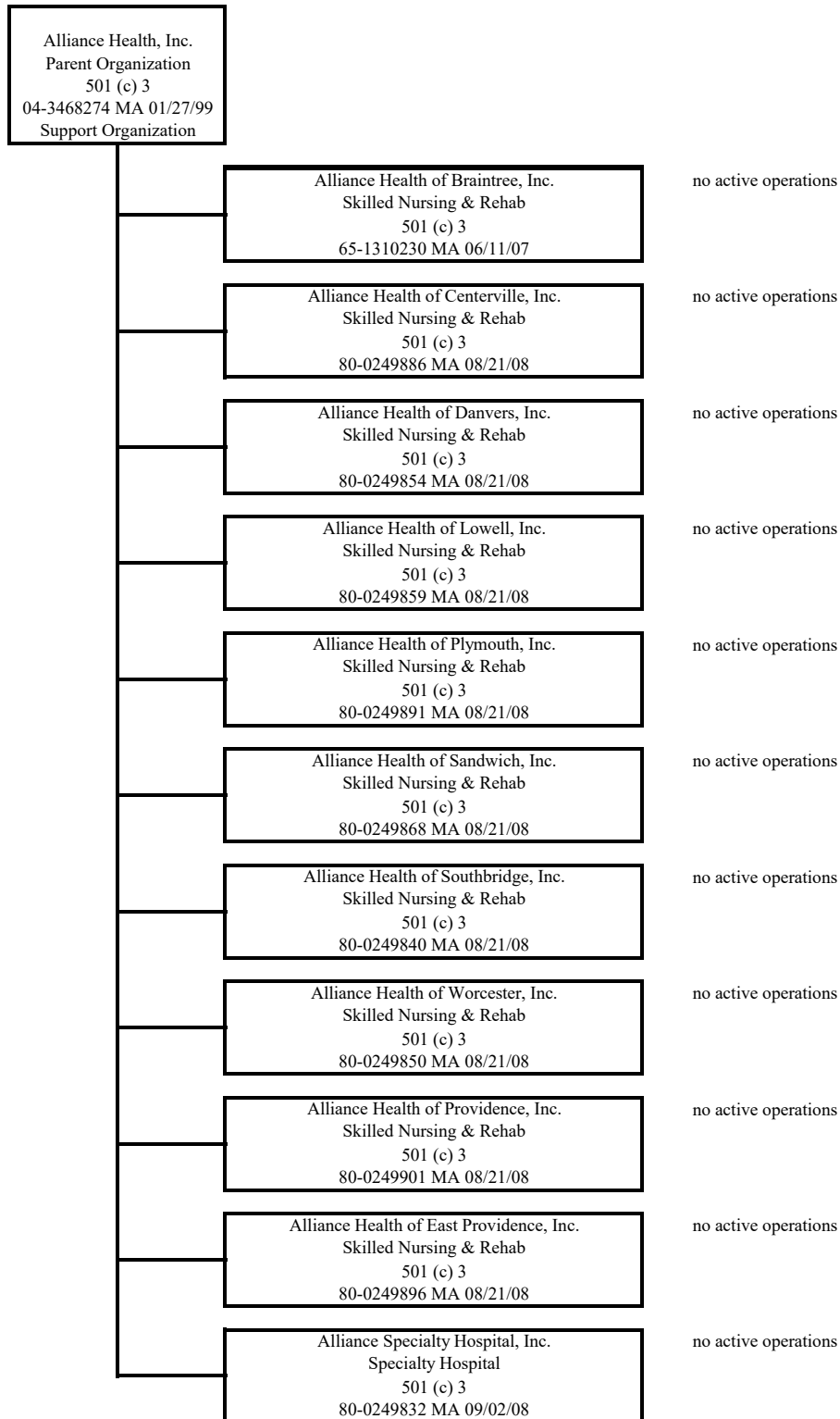
