Massachusetts Acute Hospital and Health System Financial Performance

About this Report

The Center for Health Information and Analysis (CHIA) reports on the financial performance of the Commonwealth's acute care hospitals, associated hospital health systems (HHS), and affiliated physician organizations. This report provides a quarterly update on profitability, liquidity, and solvency for the period ending December 31, 2018. Data regarding HHS and physician organizations help develop a more complete understanding of the financial performance of an acute hospital in the context of the larger health system within which it operates. This report includes 23 of the 24 HHS required to submit data. Trinity Health did not submit the required HHS data; however, Trinity did submit hospital and physician organization data. Steward Health Care, Shriners Hospital for Children and Tenet Healthcare are not included in this report as those organizations have a December 31 fiscal year end and as such, the data is not due until April 10, 2019.

Key Findings

Profitability - Hospitals

Overall acute hospital profitability¹, as measured by the median total margin, decreased by 3.3 percentage points in comparison to the same period of the prior year. This change was mostly influenced by non-operating performance, as operating margins increased for most cohorts. All four hospital cohorts² experienced a decreased median non-operating margin. In contrast, the median operating margin for 3 of 4 cohorts increased year over year.


The AMC³ cohort had the only increase in overall profitability, while the teaching hospital cohort experienced the largest decrease between last year's period and the current period.

Liquidity

All hospital cohorts reported a median current ratio above 1.0, an indication that they have sufficient current assets to meet current liabilities. Four hospitals reported ratios below 1.0 but all are part of larger health systems. None of the 23 hospital health systems that reported data had a current ratio below 1.0.



Profitability – Hospital Health Systems and Physician Organizations

Of the 23 hospital health systems that reported data, only 10 reported a profit. Of the 13 systems that reported a loss, seven reported a positive operating margin, indicating that non-operating income is an important factor in overall financial performance. The majority of HHS affiliated physician organizations (43 out of 46) reported a net loss.

For most of the hospital health systems included in this report, this data reflects their first quarter results and may not be indicative of their final annual financial performance.
