## About this Report

This report provides an update on the profitability, liquidity, and solvency of acute care hospitals, associated hospital health systems (HHS), and affiliated physician organizations for the fiscal period ending September 30, 2018. This report includes 12 of 14 hospitals required to report. Shriners Hospitals for Children did not submit data to be included in this publication. Steward Health Care submitted the hospital data, however, it did not submit the HHS or physician organization data. The remaining hospitals and health systems have September 30<sup>th</sup> fiscal year ends and as such, data for those hospitals are not due until January 2019.
