MA APCD 2026 Updates

- All APCD files including any re-submissions or overdue files must be in 2026 format (applies to reporting periods January 2023 onward).
- Due to the 2026 submission guide updates, if historical Member Eligibility (ME) production files (Submission Year prior to 2026) need to be resubmitted, please notify your liaison first so that we can understand the reason for and the scope of the resubmission(s) before sending any files.
- ME & MS files need to link using the Carrier Specific Unique Member ID (CSUMID).



MA APCD 2026 Updates

- Production files through June 2026 are due by July 31st.
- Please send any overdue files ASAP and report any issues or delays to your liaison.
- CHIA's Enrollment Trends report as well as the DOI HMO Membership report (with data through June 2026) are dependent on timely submissions of Q2 2026 data.
- Be sure to use FileSecure v7.3.4 when sending production data.



Enrollment Trends Update

- The next Enrollment Trends reporting cycle will be based on data through **March 2026** and is scheduled to be published in Fall 2026.
- CHIA is sending most Payer Verification workbooks to verify APCD eligibility data this week. Due to the transition to new Member Simplified (MS) file and new layout for Member Eligibility (ME) file, the Verification workbooks were delayed.
- The deadline to respond regarding any data issues with Verification workbooks is July 31st.
- CHIA is in communication with some payers regarding their initial data submissions through March 2026, so those Verification workbooks may be further delayed.

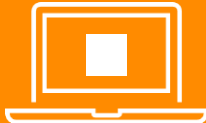
